## What to bring to your appointment

- ✓ Social Security cards for yourself, your spouse and any dependants.
- ✓ Driver license or non drivers ID for both you and your spouse. Spouses filing jointly must both be present.
- ✓ A copy of last year's federal and state tax returns
- ✓ W-2 forms for jobs held during the year.
- ✓ 1099 forms for other income such as interest, dividends, retirement, Social Security, unemployment or self-employment.
- ✓ Letters or documents from the IRS that will affect your tax returns
- ✓ Documents related to purchase of a new car or home.
- ✓ If you paid for child care – documentation listing provider name, address, tax ID#, and amount paid.
- ✓ Tuition expense statement (1098T) and/or student loan interest statement (1098E)
- ✓ Proof of expenses such as property tax, vehicle tag fees, charitable contributions, unreimbursed medical, dental or prescriptions.
- ✓ Any other documents that may be necessary to complete your tax returns.
- ✓ If you want your refund to be direct deposited bring a voided check.
